Copyright

Copyright in articles accepted and published in the *African Journal of Reproductive Health* is transferred to the Women's Health and Action Research Centre (WHARC) in accordance with the journal's Copyright Transfer Agreement.

The copyright transfer applies to the published article and materials forming part of the article, including tables, figures, graphs and other materials published as part of the article, subject to applicable third-party rights.

Authors retain the rights expressly provided in the AJRH Copyright Transfer Agreement, including applicable rights relating to personal and institutional use, educational use, and posting of the article in permitted repositories or electronic archives.

Open Access and Use of Published Articles

AJRH provides immediate open access to its published scholarly articles.

Readers may access and download published articles without subscription or payment. Users of the journal's content must appropriately acknowledge the original author(s), the article, and the *African Journal of Reproductive Health* when reproducing, distributing or otherwise using published material.

The rights granted for the use and reuse of published articles are subject to the copyright held by WHARC, the terms of the applicable Copyright Transfer Agreement, applicable third-party rights, and relevant copyright law.

Author Rights
